**CIRCULAR CALLING FOR SUITABLE CANDIDATES/ADVOCATES FOR THE
FOLLOWING POSTS**

Post of Senior Standing Counsel: - 1 (One Post)

Nature of work:- To represent the case relating to Indirect Taxation before the Hon'ble High Court of Bombay, Bench at Nagpur.

Eligibility:-

- (I) (a) Person should be enrolled/ registered as an Advocate with the High Court.
- (b) Person should have a minimum experience of five years of handling preferably Customs, Central Excise and Service Tax matters before Hon'ble High Courts or Tribunals.

OR

- (II) Have been an officer of the Customs and Central Excise Department who retired/resigned from the post of Commissioner of Customs/ Central Excise or above or retired/ resigned as Member/ Vice President/ President of CESTAT/ Settlement Commission and is enrolled/ registered as an advocate in the High Court. Provided that he has not been removed/dismissed or compulsorily retired from service on account of disciplinary action against him and no disciplinary proceeding under Service Rules or Pension Rules is pending against him.

Post of Junior Standing Counsels: - 1 (One Post)

Nature of work:- - To represent the case relating to Indirect Taxation before the Hon'ble High Court of Bombay, Bench at Nagpur.

Eligibility:-

- (I) (a) Person should be enrolled/ registered as an Advocate with the High Court.
- (b) Person should have a minimum experience of three years of handling preferably Customs, Central Excise and Service Tax matters before Hon'ble High Courts or Tribunals.

OR

- (II) Have been an officer of the Customs and Central Excise Department who retired/resigned from the post of Additional Commissioner of Customs/ Central Excise or below and is enrolled/ registered as an advocate in the High Court. Provided that he has not been removed/dismissed or compulsorily retired from service on account of disciplinary action against him and no disciplinary proceeding under Service Rules or Pension Rules is pending against him.
