## PUBLIC NOTICE No: 01/2016-CUS

## Sub: Appointment of Custodian of Import and Export Goods under Section 45(1) of the Customs Act, 1962 for Inland Container Deport, Butibori, Nagpur of M/s. Glocal ICD Pvt. Ltd., Butibori, Nagpur – Reg.

In supercession of Public Notice No. 02/2014 dated 20.01.2014, through which M/s. Glocal ICD Ltd., Butibori was appointed as "Custodian" of Imported and Exported goods under Section 45(1) of the Customs Act, 1962 received in ICD, Butibori, Nagpur until they are cleared for home consumption or warehoused or transshipped in accordance with the provision of Chapter VII of the Act, *ibid* and also for the goods intended for export till their actual exportation at the port of exit.

2. In exercise of the powers conferred under section 45(1) of the Customs Act, 1962(52 of 1962), the Principal Commissioner of Customs, Central Excise and Service Tax, Nagpur–I hereby appoints M/s. Glocal ICD Pvt. Ltd., Butibori, Nagpur (in short ICD, Butibori) as Custodian of imported goods received and / or transshipped to the said Inland Container Depot, Butibori, Nagpur. M/s. Glocal ICD Pvt. Ltd., Butibori, Nagpur shall also be the Custodian of export cargo brought into Inland Container Depot, Butibori, Nagpur for stuffing, counting, packing, customs examination, transportation and safe delivery of the cargo to the gateway ports for onward shipment to the destinations as declared in the Shipping Bill.

3. M/s. Glocal ICD Pvt. Ltd., Butibori, Nagpur shall execute a Custodian cum Carrier Bond of Rs. 8.20 Crores (Rupees Eight Crores and twenty lakhs only) with the Principal Commissioner, Customs, Central Excise and Service Tax, Nagpur-I or his authorized officer before commencing any import/export at the said ICD alongwith Bank Guarantee of Rs. 82 Lakhs. The Bond value shall, however, be subject to the satisfaction of the Principal Commissioner of Customs, Central Excise and Service Tax, Nagpur or his authorized officer in this regard, who will periodically review the performance of the Custodian. The Bank Guarantee shall be with auto renewal clause and renewed from time to time.

4. M/s. Glocal ICD Pvt. Ltd., Butibori, Nagpur shall ensure insurance of all goods held in the ICD, being the Custodian, except those goods, which have already been insured by the importer/exporter concerned. If any goods are lost or pilfered while in the custody, then in

terms of the provision 45(3) of the Customs Act, 1962, and any other provisions of the Customs Act, 1962, as applicable, the custodian, shall be liable to pay duty and other charges as leviable on such lost/pilfered goods.

5. M/s. Glocal ICD Pvt. Ltd., Butibori, Nagpur shall provide free furnished office space for the Customs Department, free transport and make adequate arrangements for sanitary facilities for the officers working for the functioning of the said ICD. The Custodian shall be liable to pay Cost recovery charges for Customs Officers as per the Rules.

6. M/s. Glocal ICD Pvt. Ltd., Butibori, Nagpur, shall not alter the premises declared as Customs area vide Public Notice No.01/2014 dated 20.01.2014 without the concurrence of the Principal Commissioner of Customs, Central Excise and Service Tax, Nagpur – I. The Custodian shall also be responsible for security of the premises as notified under afore-mentioned Public Notice dated 20.01.2014 and the goods therein at their own cost.

7. M/s. Glocal ICD Pvt. Ltd., Butibori, Nagpur, shall abide by all other instructions issued from time to time under various provisions of the Customs Act, 1962 and brief of which will be specified in a separate Public Notice in the form of procedures for dealing with import/export cargo in the said ICD.

8. M/s. Glocal ICD Pvt. Ltd., Butibori, Nagpur, being the Custodian of goods meant for Export and Import, shall always be bound to comply with the provisions of the Customs Act,1962 and Handling of Cargo in Customs Area Regulation, 2009, as well as any of the rules and regulations and instructions already issued either by the Ministry, CBEC or this office or would be issued from time to time in this regard. The Custodian shall also ever be bound by the legal provisions of the Customs Act, 1962 and any other legal provisions as made applicable to them by the Government from time to time.

9. The Custodianship of M/s. Glocal ICD Pvt. Ltd., Butibori, Nagpur will initially remain valid for 2 (two) years from today i.e. 14/01/2016, subject to the satisfaction of the Principal Commissioner of Customs, Central Excise and Service Tax, Nagpur – I who shall also have the right to terminate the said appointment at any time after assigning specific reasons for the breach of any of the provisions of the Customs Act, 1962 relating to such activity as permitted under this Public Notice and or any other Public Notices in this behalf by giving them an opportunity to explain their case. The appointment shall be reviewed after 2 years and on renewal may be extended upto a further period of 5 (five) years.
