A public disposal of AC Plant by way of inviting sealed bids of various surplus/old/unserviceable/obsolete articles will be sold on 24.09.2018 at the Office of the Principal Commissioner, GST, Nagpur-I Telangkhedi Road, Civil Lines, Nagpur.

- 1. This is for information to all concerned that as per Annexure-I (copy enclosed) Scrap/unserviceable AC Plant, situated in the premises of GST Bhavan, Civil Lines, Nagpur will be sold on 24.09.2018 by calling tender/tender-bill. In this regard Tender/Bids will be opened at 03.00 pm on 21.09.2018 in the Conference Hall of Office of the Principal Commissioner, GST, Nagpur-I Telangkhedi Road, Civil Lines, Nagpur. The highest bidder will be awarded the bid materials. The bidders are welcome to come and witness the opening of tender/bids.
- 2. The AC Plant can be inspected at site at Ground Floor, Office of the Principal Commissioner, GST, Nagpur-I Telangkhedi Road, Civil, Nagpur. The materials are offered for sale on "As is where is basis".
- 3. The bidder will have to deposit Bank Draft of Rs. 5,000/- (refundable) amount immediately. The payment should be made in form of Bank Draft drawn on any Nationalized Bank in the name of the Assistant Chief Accounts Officer, CGST & Central Excise, Nagpur I, Nagpur. The bidders whose bid is accepted, has to deposit the remaining amount in form of Demand Draft within 3 days of successful of the bid in favour of the Assistant Chief Accounts Officer, CGST & Central Excise, Nagpur I, Nagpur.

General terms & conditions for sale of scrap/unserviceable materials.

The bidder is requested to go through the following conditions and submit the same with the tender signing each page in token of having gone through the conditions and his acceptance of the same.

- 1. (A) The bidder whose bid is accepted will have to deposit 25% amount of the accepted amount immediately in the form of bank draft drawn on any Nationalized Bank payable at the Assistant Chief Accounts Officer, CGST & Central Excise, Nagpur I, Nagpur and the remaining amount within seven days of the approval of the bid. If the bidder and materials and the amount of deposit paid by him would stand forfeited.
- (B) The material can be inspected at any working days (except Saturday/Sunday & closed holiday) from 03.00 pm to 05.00 pm from 18.09.2018 to 19.09.2018.
