## Sub: Monitoring of realization of export proceeds for the Drawback EDI Shipping Bills – Submission of certificates/negative statements for the shipments having LEO dates from 1.4.2013 to 31.3.2014– Reg.

1. Attention of all exporters is hereby invited to the CBEC's Circular No. 5/2009 Cus. dated 2.2.2009, which provides the detailed guidelines / procedure regarding system alert for monitoring realization of export proceeds in EDI. Subsequently, CBEC, vide Instruction dated 27.11.2015 issue vide F. No. 609/59/2012-DBK, has directed for feeding of details of EDI shipping bills with LEO date from 01.04.2013 to 31.03.2014 by the field formations.
