Sub: Appointment of Custodian of Import and Export Goods under Section 45(1) of the Customs Act, 1962 - Regarding

In exercise of the powers conferred under Section 45 (1) of the Customs Act, 1962, M/s. Distribution Logistics Infrastructure Pvt. Ltd., Integrated Logistics Park, ICD, Borkhedi, Nagpur – 441108 are appointed as "Custodian" of imported goods received in Inland Container Deport, Borkhedi until they are cleared for home consumption or Warehoused or transshipped in accordance with the provisions of the Chapter VII of the Act, *ibid* and also for the goods intended for export till their actual exportation at the port of exit.

- 2. M/s. Distribution Logistics Infrastructure Pvt. Ltd., Borkhedi, Nagpur as the Custodian of Goods would be required to comply with the provisions of Section 45(2) of the Customs Act, 1962 and Handling of Cargo in Customs Areas Regulations, 2009 (as amended) as well as Rules, Regulations and Instructions issued from time to time on the subject.
- 3. M/s. Distribution Logistics Infrastructure Pvt. Ltd., Borkhedi, Nagpur shall be liable to pay duty, if any imported goods are pilfered after unloading thereof, as per the provisions of Section 45(3) of the Customs Act, 1962.
- 4. The Custodianship will initially remain valid for 2 (two) years from today i.e 05/04/2016, subject to the satisfaction of the Commissioner of Customs, Central Excise and Service Tax, Nagpur–II who shall also have the right to terminate the said appointment at any time after assigning specific reasons for the breach of any of the provisions of the Customs Act, 1962 relating to such activity as permitted under this Public Notice and or any other Public Notices in this behalf by giving them an opportunity to explain their case. The appointment shall be reviewed after 2 years and on renewal may be extended upto a further period of 5 (five) years.
