PUBLIC NOTICE

This office has initiated a process of appointment of Special Public Prosecutors (SPPs) for handling cases of Criminal/Prosecution before the High Court of Nagpur and Subordinate Courts/Courts of Session falling under the jurisdiction of the CGST Commissionerates of Nagpur-I/ Nagpur-II/ Customs Commissionerate in term of Instructions/ Guidelines issued by the Government of India, Ministry of Finance, Department of Revenue, Central Board of Excise and Customs, New Delhi vide F.No. 278A/54/2015-Legal, dated 29.02.2016. All the aspiring advocates who have been practicing as an advocate for not less than 10 years & also qualify in terms of Section 18(8) of the BNSS, 2023 to the Bar Council of the High Court of Nagpur/ bar association of Subordinate Court falling under the jurisdiction of the CGST Commissionerates of Nagpur-I, Nagpur-II and Customs Commissionerate, Nagpur can apply.

The applicants should apply along with the Bio-data in Proforma-A along with all relevant documents and willingness to the Principal Commissioner of CGST & Central Excise, Nagpur-I so as to reach on or before 31/03/2025. The advocate desiring to apply for selection of more than one subordinate courts/Courts of Session, as mentioned above, needs to mention the same in their application..

The first engagement of an SPP shall normally be for a period of 18 months. Such engagement will be renewable on receipt of recommendation of the concerned Chief Commissioner along with the annual performance appraisal on completion of first 12 months of the engagement.
